### DUBOIS COUNTY SWCD NO-TILL DRILL RENTAL AGREEMENT

The Dubois County Soil and Water Conservation District (Lessor), 1486 Executive Blvd. Suite A, Jasper IN 47546, leases to the undersigned customer (Lessee) the following described No-Till Drill Equipment:

**TERMS**  
The Lessee is responsible for transporting the no-till drill to and from the Dubois County Soil and Water Conservation District office. When the Lessee schedules the no-till drill, office personnel will specify when the no-till drill is to be returned. If the Lessee does not return the no-till drill to the SWCD office prior to or at the specified time without prior permission, Lessor will be assessed a late fee of \$75.00. The Lessee may rent the drill for 3 days with no fee, after the third day, a \$25 per day fee will be assessed.

The Lessee at own cost and expense will use the no-till drill in a careful and prudent manner keeping the same in good repair. The Lessee agrees to clean all seed out of the seed boxes prior to returning the drill. A \$50 penalty will be assessed for any seed box not cleaned upon return. The no-till drill will be operated at all times by an experienced and competent operator. Lessee will comply with all laws and regulations relating to the use and operation of the no-till drill.

Lessee is not responsible for lubricating the no-till drill. The Lessee is responsible for repair costs for damage to the no-till drill if the SWCD Board of Supervisors determines that the damages are not normal wear and tear. The Lessee will also be responsible for damages resulting from incorrect or unsafe use of the no-till drill, whether during use in the field or during transport on public and/or private roads. If the no-till drill becomes unusable during rental period, Lessee can contact SWCD Associate Supervisor Alan Smock 812-639-1834 for technical assistance. If Lessee is unable to reach Smock, Lessee is to contact the SWCD office for further direction. Lessor is responsible for repairs to no-till drill. Lessor is NOT responsible for service call fees if the Lessee chooses to contact a local business for repairs to the drill.

In the event inclement weather makes it impossible to use the no-till drill, SWCD office personnel will reschedule drill use in the order originally scheduled.

The Lessee agrees that all invoices in excess of thirty days past due from billing date will result in a denial of rental privileges from all SWCD equipment, as well as eligibility for SWCD programs until balance is paid in full.

**Assumption of Risks: It is understood and agreed that the Lessee is an independent contractor and is not the agent, servant, or employee of the Lessor. The Lessee is responsible for the no-till drill while it is in his/her care, custody, and control. The Lessee assumes all risks resulting from the use of the no-till drill and agrees to indemnify and save harmless Lessor from any and all liability for injury to persons or damage to property caused by the no-till drill or the use thereof.**
